3. Topsoil

All topsoil was used in reclamation.

4.a Hydrologic Balance: Diversions

Diversions were spot-checked and were functioning as designed. There is approximately seven inches of snow cover.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment pond did not contain water. No hazardous conditions were noticed during my inspection.

4.c Hydrologic Balance: Other Sediment Control Measures

The reclaimed area is pocked to prevent sediment from leaving the site.

UPL has installed a pipeline next to the main to the reclaimed refuse site. They have left some non-coal waste material next to the reclaimed area. The permittee is making plans for its removal.
