Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

Willow Creek Mine has received Phase II bond release on August 15, 2012 by the Division. The only area which did not receive Phase II bond release was the Shaft area at Crandall Canyon. This area was disturbed for backfilling the shaft.

The permittee had a survey conducted on the shaft area in November 2012. The area settled 1.2 feet in three years. The shaft will be surveyed annually to check for subsidence of the shaft area. The shafts appear to be stable and no change since the last inspection.

No violations were issued.

1. Permits, Change, Transfer, Renewal, Sale

There are no permitting actions taking place with the Division at this time.

2. Signs and Markers

I inspected identification signs at the gate to Crandall Canyon, the topsoil barrow area along highway US 50-6, and next to the road along Indian Canyon. The signs meet the minimum requirements of the R645 Coal Rules.

3. Topsoil

All available topsoil was used in reclamation. I did not see any signs of erosion to the topsoil. The soil appeared to be stable.

4.a Hydrologic Balance: Diversions

All diversions were opened. They were stable and did not see any signs of erosion. The diversions were dry with no water flow. The diversions are grass lined and have rip rap.

8. Noncoal Waste

The reclaim site was clear of non-coal waste materials.

10. Slides and Other Damage

The shaft areas at Crandall Canyon appear to be stable. This has not change since I have been inspection this reclaim site. The permittee will be surveying the shaft sites this year to monitor if there is subsidence.
