
Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

Dense vegetation and pocking on top of both shaft's disturbed areas has stabilized sediment and prevented it from leaving the permit area.

Dense vegetation was showing through 8" of snow.

No subsidence cracks were observed and both shafts appeared to be stable.
