1. Permits, Change, Transfer, Renewal, Sale

The current Willow Creek Mine permit was approved for renewal on March 8, 2016 and the insurance for the mine is maintained with National Union Fire Insurance Company of Pittsburgh, with an expiration date of 07/25/2017. The insurance includes the minimum coverage including explosives and coverage due on occurrences. Approval for Phase III Bond release would allow the permittee to reduce the bond held for the site to \$10,452. The remaining 1.19 acres in the permit was last re-disturbed in 2008 therefore Phase II cannot be applied for until 2018.

The company sign was present at the gate with all the correct ownership and contact information
