Dear Mr. Haddock:

I have enclosed five copies of an amendment to BLM Right-of-Way UTU-77985 for incorporation into Appendix 1-3 of the Dugout M&RP. This right-of-way was originally granted by the BLM on August 14, 2000 for the construction of a pipeline and leach field to process wastewater from the Dugout Canyon Mine. The right-of-way was also accepted by the Division for incorporation into the M&RP on September 18, 2000. Unfortunately, during preparation of our Leach Field Addendum, it was discovered that the original right-of-way did not accurately describe the BLM property required for the proposed facility. The enclosed amendment corrects this discrepancy.

Please be aware, that this corrected right-of-way now completes the right-of-entry information for our Leach Field Addendum A-1. This Addendum was submitted to the Division on March 26, 2001 and is currently under review.




