Attached please find five copies of Exhibit A and Exhibit B to replace the same exhibits in Appendix 2-7. In addition five copies of Plate 2-3 have been included to replace the plate of the same number in Chapter 2.

The Exhibit A and Exhibit B drawings are being submitted to update the permit to show the surveyed footprints of the topsoil storage piles at the Soldier Canyon/Dugout Canyon stockpile. Plate 2-3 is being submitted to show the intended location for the riparian soil and the rock to be removed during the stream realignment and pad construction of the Gilson Well Project. The rocks are naturally occurring and are associated with the natural soils of the area. All rocks will be returned to the Dugout Mine site during reclamation.

In addition pages 5 and 13 of Appendix 2-7 have been include for replacement. Both redline/strikeout and clean copy versions have been included.

The stockpile expansion was approved effective October 16, 1998 (ACT/007/018-98C) and the Gilson Well Project was approved on February 6, 2002 (C/007/039-AM01H)
