Vicky - I e-mailed you too soon. Linda Keene just got an audit yesterday (April 12) from the AVS audit section that shows that Canyon Fuel has incorrect information in the AVS and forwarded me that information this morning. This information is dated May 23, 2003 from Data report sheets from Canyon Fuel.

So the information you provided for Chapter 1 CANNOT be approved. I will fax you the information this morning. You may need to get additional updated information from the Canyon Fuel and/or Arch, which you will have to get from the appropriate folks at Canyon Fuel and/or Arch.

So - It is back to the drawing board. (As I mentioned before, the Dugout SITLA lease can't be approved until AVS is current).

Linda Keene noted that Larry Emerson keeps the eastern operations for Arch up to date in AVS. You may want to contact him and find out where he gets all of his information. Thank you.
