4.a Hydrologic Balance: Diversions

All of the diversions which were inspected this day appeared capable of functioning as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Nielson Construction Company will be mobilizing equipment in the next several days to initiate the cleaning of the surface facilities sediment pond. The water in this pond has been sampled to determine the effluent parameters. The sediment pond at the waste rock site had small pools in the bottom. The sediment basin at the Pace Canyon fan portal facility was dry. There were no compliance issues identified for any of the three impoundments.

4.d Hydrologic Balance: Water Monitoring

The Permittee is currently inserting water monitoring information for the first quarter of 2007 into the DOGM data base "pipeline. Second quarter field monitoring activities are currently being conducted. The upper left and right forks of Dugout Creek had small flows, as observed this day.
