2. Signs and Markers

Identification signs at Pace Canyon was inspected. It complies with the R645 Coal Rules.

4.a Hydrologic Balance: Diversions

Several of the diversions were inspected and recently cleaned out. There are others in shady areas still frozen and will need to be cleaned out in the near future.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment pond at the mine site was inspected with no hazardous conditions noticed during the inspection. This pond did contain water but was not discharging during the inspection.

4.d Hydrologic Balance: Water Monitoring

The fourth quarter water monitoring was submitted to the Divisions.

4.e Hydrologic Balance: Effluent Limitations

The mine was not discharging water out of Pace Canyon portals during the inspection.

8. Noncoal Waste

The mine site was clear of non-coal waste material.

10. Slides and Other Damage

No slides or other damages were noticed during the inspection.

16.b Roads: Drainage Controls

Ditches at the sub-station had run off and were functioning as designed.
