2. Signs and Markers

The identification sign for Dugout Mine is located at the main gate.

3. Topsoil

I inspected all the topsoil piles for the Dugout Mine and there were no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

Several of the diversions were cleaned out at the Dugout Mine. Several others will be cleaned out in the near future. All diversions would function as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond was filled with water but was not discharging during the inspection. No hazardous conditions were noticed during the inspection.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected. No hazardous conditions were noticed during the inspection. The sediment pond at the site was dry. No hazardous conditions were noticed.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or other damages were noticed during the inspection.

16.b Roads: Drainage Controls

Road drainage was functioning as designed.
