The permit sign is located at the gate to the property. Information meets the minimum requirements of the R645 Coal Rules.

18. Support Facilities, Utility Installations

I inspected the following de-gas sites: G-11 is an equipment storage, G-12 is inactive, G-29 not constructed, G-25 has pump on site but inactive and equipment will go to G-30. G-30 is construction waiting on drillers and equipment. This should take place the 1st of October. I inspected Exp #0109 and is completely reclaimed. G-9 is reclaimed, G-10 is currently in reclamation, G-17 is a topsoil pile and planted and fenced off, G-16 is not active and still has cutting, G-22 is not active and has cutting, G-13 reclaimed, G-15 is used as a storage area. In general all sites have sediment control and appear to be stable. The technical staff visited G-14, G-19, AMV road, G18 and G-31. Information on these site please see staffs review. I went to the following de-gas pads: G11,G12,G25,G26,G18,G19,and G30 in August. All site appear to be stable and no sediment was leaving the sites. The only site which have not been inspected are G1 thru G-5. These site have been reclaimed. I will conduct an inspection on these sites on the next partial inspection, if weather permits.
