The mine site is covered with snow. Diversions contain natural fallen snow within the ditches.

Several pieces of Longwall mining equipment is outside the mine. The equipment will be transported to other Arch mines to be used in the mining process of that facilities.

It is anticipated that in Febuary of 2013 a single miner section will conduct mining at the Dugout mine. Before this can happen the permittee must seek MSHA approval for pillar and ventilation.

2. Signs and Markers

The permit sign is located at the gate to the property. Information meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

The topsoil piles at the mine site was snow covered. There were no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

The diversions were snow covered. I could not see any water flow within the diversions. The culverts were spot checked and were open for water flow.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond contained water and could discharge if there was a warming trend. I did not see any hazardous conditions to the sediment pond. The embankments were snow covered.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse piles was snow covered and no activity occurred since the last inspection. No hazardous conditions were noticed. The pile appear to be stable. The permittee may move snow from the mine site to the refuse pile site.

8. Noncoal Waste

The mine site was clear of non-coal waste material. If there is non-coal waste on the site; it is snow covered.

10. Slides and Other Damage

I did not see any slides or other damage during the inspection.
