2. Signs and Markers

I reviewed the identification signs at the mine, the information on the sign meeting the minimum requirements of the R645 Coal Rules. It is next to the gate entering the mine site. There are also identification signs at the refuse pile and topsoil pile. The information is the same on all signs.

3. Topsoil

I inspected the topsoil piles at Dugout mine. The piles were stable and there were no signs of wind or water erosion. The piles could use some rainfall.

4.a Hydrologic Balance: Diversions

All diversions and culverts were open. There was a person cleaning out a diversion during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond at the mine site was clean out since the last inspection. It contained water but was not discharging during the inspection. The refuse sediment pond was totally dry. No hazardous conditions were noticed.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile and no hazardous conditions were noticed. The slopes appear to be stable.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

16.a Roads: Construction, Maintenance, Surfacing

The road to the main office has developed several pot holes. The permittee plans to patch these pot holes.

16.b Roads: Drainage Controls

Road drainage was open and would function in a storm event.

18. Support Facilities, Utility Installations

There were no new facilities since the last inspection.
