I did not see coal trucks being loaded out today. There was a big stock pile of coal at the mine.



## **2. Signs and Markers**

I reviewed the identification signs at the mine, the information on the sign meeting the minimum requirements of the R645 Coal Rules. It is next to the gate entering the mine site. There are also identification signs at the refuse pile and topsoil pile. The information is the same on all signs.

## **3. Topsoil**

I inspected the refuse piles during the inspection. They were stable with no signs of wind or water erosion. The topsoil piles did have some vegetative cover. There has been less rag weed on the topsoil piles this year than previous years.

### **4.a Hydrologic Balance: Diversions**

The diversions and culverts were open. They have been recently clean out of sediment and small rocks. The diversions would function as design.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The sediment pond at the mine site contains water but was not discharging during the inspection. The embankments were stable. I did not see any hazardous conditions to the stability to the sediment pond.

The waste rock sediment pond did not contain water. The slopes were stable with no signs of any hazardous conditions.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile was idle and not in use. The out slopes of the refuse pile were stable. I did not see any hazardous condition during the inspection.

## **8. Noncoal Waste**

The mine site was clear of non-coal waste materials.

### **16.b Roads: Drainage Controls**

All road drainage was functioning as design. The diversions and culverts were open.
