### **PROPOSAL**

Bowie Resource Holdings, LLC, a Delaware limited liability company, purchased 100% of the equity interests of Canyon Fuel Company, LLC from Arch on August 16, 2013. Canyon Fuel Company, LLC submitted an application to transfer the permits of Canyon Fuel Company, LLC owned mine sites reflecting the ownership transfer from Arch to Bowie Resource Holdings, LLC.

### **PUBLIC NOTICE**

The applicant published notice of the permit transfers on November 5, 2013 in the Emery County Progress, on November 6, 2013 in the Richfield Reaper and on November 7, 2013 in the Sun Advocate. No comments, objections, or requests for informal conference were received by the Division during the 30-day comment period.

### **AVS CHECK**

A review of the AVS system was conducted on December 13, 2013. The system showed that there were no outstanding violations for Canyon Fuel Company, LLC or Bowie Resource Holdings, LLC.

### **RECOMMENDATION**

The Division made the decision on December 13, 2013 to approve the permit transfer on the fact that 1) The terms and conditions of the existing permit are being satisfactorily met; 2) The present coal mining and reclamation operations are in compliance with the environmental protection standards of the State Program; 3) The transfer does not substantially jeopardize the operator's continuing ability to comply with the State Program on existing permit areas; and 4) The operator has provided evidence of having liability insurance and a performance bond which will be in effect for the operation and will continue in full force and effect.




