## **2. Signs and Markers**

The mine identification signs at the main entrance, Waste Rock Site and Topsoil pile were checked on the inspection. The sign at the topsoil pile has been replaced with a new sign. The information is accurate on the new sign, as well as the existing signs.

### **4.a Hydrologic Balance: Diversions**

The diversions along the roadways were checked and found to be open and functional. Many of the diversions at the main facilities are concrete lined.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The main sediment pond contained water and is iced over with the cooler temperatures.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The waste rock site was inspected. At the time of the inspection no activity was occurring. The diversions and roadways with berms were well maintained.

The need to expand the waste rock site has become more prevalent. Information to make a minor and then a major expansion are actively being prepared.

## **22. Other**

Annual training including environmental awareness was conducted today at the mine site.
