

2. Signs and Markers

The mine identification signs at the refuse pile and main facilities were both observed and checked for current information and content against the requirements set forth by the regulations. Both signs were found to be legible, accurate and contained all of the required information.

4.a Hydrologic Balance: Diversions

The surface diversions along the roadways were observed and found to be functional. Care had been taken during snow removal activities to not push, place and/or plow snow into the diversions.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond contains water. The cooler temperatures has frozen the surface of the pond. The sediment pond dikes appear stable. No visible hazards were present at the time of the inspection.

5. Explosives

The powder and cap magazines were both observed. Care has been placed to post the explosive signs in manner that is in compliance with the regulations. The signs are placed/posted so that if a bullet/projectile would pass through the sign it would not enter the magazine. The magazines are also properly grounded in the event of a lighting strike.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was checked during the partial inspection. The pile appears stable. No visible hazards were observed. The mine is planning a minor expansion and a major expansion in the near future.

22. Other

Added care has been taken at the fuel storage and dispense station by the operator to insure that fuel containment with inside of the designed structure is achieved. This has been accomplished by training of employees about proper usage and care during usage and to make sure that the equipment is placed in and maintained appropriately.
