2. Signs and Markers

The mine identification signs at the Waste Rock site/refuse pile and the main mine facility are both posted at the entrance into the mining permit area. Both of the signs are up to date and contained all of the required information.

4.a Hydrologic Balance: Diversions

The road diversions at the main facility were checked as part of the partial inspection. The diversions observed were open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond contains water and still remains iced over even with the warmer winter temperatures.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected. No recent activity has taken place (placement of new refuse). The refuse pile appears stable. No visual hazards were observed during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

The dirt roads around the main mine facility are damp and/or muddy with the warmer temperatures melting the snow and ice. The road ways are travelable and maintained .
