2. Signs and Markers

The mine identifications signs located at the Dugout Mine and Dugout Waste Rock site were checked as part of the inspection. The signs are clearly posted at entrance into the mining permit area and contained the name, address, phone number and mining permit number as required by law.

4.a Hydrologic Balance: Diversions

The main diversions at the Dugout Mine on either side of the pad areas were checked and found to be fully functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond located at the Dugout Mine was inspected. The pond did contain water. The embankment appeared stable. No signs of instability were observed.

5. Explosives

The storage area for the storage of explosives is located up-canyon from the main facilities. The area was visited and the powder and cap magazines were properly grounded. The signs located at the magazines compile with the regulations.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was inspected and the top is all graded off and compacted. No signs of instability were observed.

8. Noncoal Waste

The Dugout Mine was free of noncoal waste items outside of approved containment areas.
