2. Signs and Markers

The mine identification signs at the mine site and the waste rock site were observed as part of the partial inspection. Both signs were found to be compliant with the coal rules.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Sediment pond is snow covered. Surface of pond is snow over ice. It was snowing during the inspection.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile was receiving waste rock material during the partial inspection. The small expansion has been approved and the new waste rock is dumped on top of the existing refuse pile and then pushed down the slope by a bull dozer into the new expansion area.

16.a Roads: Construction, Maintenance, Surfacing

Roads leading to and at the mine site are snow packed. Toward the end of the inspection snow plows were actively removing the snow from the roadways.
