2. Signs and Markers

The mine identification signs were in place at points of public access at the waste rock site and at the Dugout Mine. Both sign locations clearly post the name, address, phone number and mining permit number as is required within the regulations.

4.a Hydrologic Balance: Diversions

The diversions at the waste rock site and at the Dugout Mine were inspected. Some of the diversions at the Dugout Mine contained ice from freezing temperatures. All observed diversions were open and fully functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond at the waste rock site had a slight amount of ice in the bottom of the pond toward the embankment. The sediment pond at the Dugout Mine was frozen over. The ice level was way below the decant elevation of the pond. Both embankments appeared stable. No visible hazards were observed.

5. Explosives

The powder and cap magazines used to store explosives were inspected as part of the partial mine site inspection. The magazines are grounded against a lightning strike. The identification signs are posted in a way that a bullet or projectile going through the sign will not enter the magazines. Both of these features are requirements set for the CFR (code of federal regulations).

7. Coal Mine Waste, Refuse Piles, Impoundments

The waste rock gate was open during the inspection so that the site could receive waste material. No trucks were observed, but a caterpillar operator was on site working the pile. Material is currently being pushed down the slope into the waste rock expansion area. The pile appears stable. No visible hazards were observed during the partial inspection.
