CANYON FUEL COMPANY, LLC'S UNOPPOSED MOTION FOR EXTENSION OF TIME

Pursuant to 43 C.F.R. §§ 4.22(f) and 4.405, Canyon Fuel Company, LLC ("CFC") hereby requests a 30-day extension of time in which to file its Statement of Reasons. Absent an extension, CFC's Statement of Reasons would be due on February 20, 2017. 43 C.F.R. § 4.412(a). With the 30-day extension, CFC's Statement of Reasons will be due on March 22, 2017. As required under 43 C.F.R. § 4.405(c), counsel for CFC conferred with counsel for the Bureau of Land Management ("BLM"). BLM indicated that it does not oppose this extension.

Good cause exists for an extension of time in this case. CFC and BLM are currently negotiating a potential resolution that may obviate the need for this appeal but do not anticipate that they will be able to reach an agreement before CFC's February 20, 2017 deadline. Accordingly, this request is not being made for reasons of delay or for any other dilatory purpose, will not prejudice either party, and will further the interests of justice.
