2. Signs and Markers

Identifications were present at the waste rock site and main mine facility. The signs display the name, address, phone number and mining permit number of the operator.

4.a Hydrologic Balance: Diversions

Diversions observed were open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond is scheduled to be cleaned August 5th and 6th

5. Explosives

Explosive storage area contained powder and cap magazines and a trailer used for transportation underground when needed. The powder and cap magazines are locked and secured. The area is properly signed. The magazines are grounded as a protection against lightning strikes.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards were observed. The roadways were being watered during the inspection.

8. Noncoal Waste

The mine site and waste rock area were free of noncoal waste items.
