2. Signs and Markers

Two identification signs were checked during the partial inspection. Both these signs displayed the name, address, phone number and mining permit number for the Dugout mine operator. The signs are in compliance.

4.a Hydrologic Balance: Diversions

Diversions at both locations visited (waste rock site & mine site) were open and functional.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond contained water. All of the other sediment ponds checked were dry.

5. Explosives

The explosive store area was checked. The magazines are grounded and have signs placed to identify the area.

7. Coal Mine Waste, Refuse Piles, Impoundments

The waste rock site was active during the inspection. The pile is well graded and compacted.
