## **2. Signs and Markers**

The mine identification signs at the waste rock site and the mine site were inspected for completeness. Both signs list the name, address, phone number and mining permit number of the operator. The signs are in compliance with the coal rules.

## **3. Topsoil**

There is a subsoil pile located on top of the refuse pile. This pile is not shown on the surface facilities map. Verbal approval was given by the Division for placement of this pile during Phase 1 of the expansion project. This placement was not addressed under a permit amendment. Discussions of this pile are also listed on the courtesy inspection conducted on 12/3/2019.

### **4.a Hydrologic Balance: Diversions**

Diversions at the mine site and at the waste rock site were checked. The diversions at the mine site are snow covered, but open and functional. The diversions at the waste rock site are functional.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The sediment pond at the mine site contained water with the surface being frozen. The sediment ponds at the waste rock site were dry.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile was well graded and compacted at the time of the inspection. No visible hazards were observed.
