2. Signs and Markers

The mine identification signs at the mine site and at the waste rock site were checked during the partial inspection. Both of these signs contained the name, address, phone number and permit number as required by law. The signs are in compliance.

3. Topsoil

The topsoil and sub soil piles that were located at the base of the waste rock pile adjacent to the sediment pond have been moved to the top surface of the existing waste rock pile. Currently there is no berm for protection or signs for identification. The berm and signs are to be installed in the near future. Placement of these piles is now close to the existing temporary subsoil pile that was on the surface of the waste rock site.

The topsoil and subsoil piles were moved to allow further expansion of the waste rock pile

4.a Hydrologic Balance: Diversions

All of the diversions are snow covered at the mine site and ad the waste rock site.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The mine sediment pond contained water and is ice and snow capped. The sediment ponds at the waste rock site are dry except for a dusting of snow cover.

7. Coal Mine Waste, Refuse Piles, Impoundments

Topsoil and subsoil piles from the base of the waste rock site have been moved to the surface of the waste rock site.

The pile was actively being groomed and compacted. The pile appeared stable. The site was receiving material.
