2. Signs and Markers

The mine identification signs located at the waste rock site and at the mine site were both checked during the partial inspection. Both of these signs displayed the name, address, phone number and mine permit number from the Division. These features are required by law to be posted for the public information. The signs are in compliance with the requirements of the law.

4.a Hydrologic Balance: Diversions

Diversions should be monitored as the area starts to thaw to ensure that the build-up in the diversions is ice and not sediment accumulations.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond located at the mine site contains water. The ice cap on the surface is beginning to melt with warmer temperatures. Both ponds at the waste rock site were dry. All embankments appeared stable.

5. Explosives

The explosive storage area was checked. The area has signs to identify the area as an explosive storage area. The magazines are grounded to the ground against lightning strikes.

7. Coal Mine Waste, Refuse Piles, Impoundments

The waste rock site was inactive during the partial inspection. The area is well graded and compacted.
