## **2. Signs and Markers**

The identification signs at the waste rock site and at the main site were checked for compliance. Both signs contained the name, address, phone number and mining permit number.

## **3. Topsoil**

The topsoil and subsoil piles that were moved on top of the waste rock pile last year have been seeded.

### **4.a Hydrologic Balance: Diversions**

Recent maintenance work has been done at the main mine site. All diversions are open and functional.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The main sediment pond contained water. Both sediment ponds at the waste rock site were dry.

## **7. Coal Mine Waste, Refuse Piles, Impoundments**

The extension area at the waste rock site was active. Personnel were working on site. The pile is well graded and compacted.
