2. Signs and Markers

The new mine ID signs were posted at the pump house and the main mine entrance. The new signs contained the new address and phone number.

4.a Hydrologic Balance: Diversions

The diversion located at the truck load out pad has ice accumulations at the contact point with the outlet from the crusher pad. The wash down water comes down at a slow rate allowing the water to freeze and build. The operator will remove the ice in the diversion so that the outlet still functions.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The cat walk for cell B of the sediment pond still needs to be installed to bring this structure into compliance with the approved MRP.

8. Noncoal Waste

Noncoal waste was present in the diversion adjacent to the noncoal waste storage area. The operator will have the material removed and placed back inside of the appropriate storage facility.

14. Subsidence Control

The operator provided copies of the notification of subsidence letters during the inspection. The information was forwarded to the Division main office. The letters of notification are kept on file at the mine office.
