2. Signs and Markers

Mine ID signs are located at the pump house and the entrance to the mine site from the county road. The signs contain the permit number, address, and phone number of the operator. Other signs and markers observed during the inspection meet the coal rules.

4.a Hydrologic Balance: Diversions

The diversions remain functional according to the designs in the approved MRP. The area has received several rain storms during the past month.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Checked the mine water elevation in cell A of the sediment pond to assure that it was below the maximum mine water marker. This marker has been installed to assure that the sediment pond retains enough storage capacity for the designed storm event.

4.d Hydrologic Balance: Water Monitoring

First quarter 2004 water monitoring has been entered and uploaded into the EDI website. Water monitoring is current.
