4.b Hydrologic Balance: Sediment Ponds and Impoundments

The Carbon County area received a significant rainfall event on Saturday, 9/22 and Sunday. Both cells of the pond contained quite a bit of water. Neither was close to the discharge elevation. No compliance issues were noted.
