4.a Hydrologic Balance: Diversions

Some of the sites diversions were functioning as designed this day. Other\$remain under compacted snow. The clearing of snow from the office pad parking area produced heaped snow around the drop inlet diversion located on the NE end of the pad (drains to undisturbed bypass culvert UC-00, identified on Plate 7-2). The inlet was not capable of functioning. Mr. Shaver contacted surface personnel who removed enough snow from the inlet perimeter to allow melt water to report as designed. This was done prior to the end of the inspection.
