1. Permits, Change, Transfer, Renewal, Sale

The Permittee submitted a revised surface facilities map to the Division on August 13, 2008. The map contains two minor revisions including the addition of a fenced cable storage facility on the crusher pad, and the designation of the interior of the truck loading loop as an equipment storage area. Longwall shields from the Aberdeen Mine are being stored in this area at the present time.

3. Topsoil

The Permittee has fulfilled the abatement requirements of N 10025 by removing the coal which was pushed above the crest of the cut bank in the left hand fork coal storage area. The work appears to have been completed by hand, as no gouging of the soil or vegetation appears to have occurred.

4.c Hydrologic Balance: Other Sediment Control Measures

The Permittee has installed excelsior log booms in the ditch paralleling the toe of the cut slope below the administration building. These replace the straw bales which had been previously used.
