4.a Hydrologic Balance: Diversions

Diversions were spot inspected and meet the R645 requirements.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond was inspected with no hazardous conditions noticed during the inspection.

4.c Hydrologic Balance: Other Sediment Control Measures

The permittee has added coal fines to the stream channel outside the permit area. The coal fines came from the underground mine discharge water.. The permittee notified the Division prior to the inspection. Coal fines were throughout the channel for 2-3 miles past the mine site. There were small deposits of coal fines some 4 miles away against the bank of the stream. A violation was issued for additional contributions of sediment to stream flow outside the permit area. The stream is classified as an ephemeral. There are no fish in the stream. The only time water flows down the channel other than mine discharge is due to a large storm event. The mine discharge has been continuous for the past five years.

4.e Hydrologic Balance: Effluent Limitations

The Department of Water Quality will be issuing a violation for exceeding TSS and iron standards in the UPDES permit.
