The DOGM permit will expire on April 1, 2014. Air Quality Permit is DAQE-055-99.
The UPDES Permit will expire on April 30, 2011.

4.a Hydrologic Balance: Diversions

The diversions were recently cleaned since the last inspection. The permittee will need to clean out culverts since sediment has started to build-up.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond was inspected for the first quarter on March 31, 2009.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

16.b Roads: Drainage Controls

Road drainage was functioning as designed.

18. Support Facilities, Utility Installations

No new facilities were constructed since the last inspection.

20. Air Quality Permit

The Air Quality permit is DAQE-055-99.

21. Bonding and Insurance

The insurance policy will expire on June 1, 2009. The permittee has requested the signed copy of the Reclamation Agreement from the Division. The bonding
