4.a Hydrologic Balance: Diversions

The diversions were recently cleaned since the last inspection. The permittee will need to clean out culverts since sediment has started to build-up.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond was inspected for the first quarter on June 30, 2009.

4.d Hydrologic Balance: Water Monitoring

The permittee has submitted second quarter water data to the Division. The information is ready for download.

4.e Hydrologic Balance: Effluent Limitations

The permittee had been out of compliance with TDS and total iron at the first of the year. Water quality issued a violation. Since the permittee is in compliance.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

The subsidence report is in the annual report.
