#### Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

Division representative Ingrid Campbell and West Ridge Resources Manager, Dave Shaver inspected the catchments and stream segments. The Division issued an Notice of Violation for excess coal fines being discharged into the C canyon drainage from the mine. The permittee was ordered to clean the stream by reconstructing two catchments (C and E) and brooming coal fines into the catchments. A chemical flocculent was added to the stream just before each catchment in order for the coal fines to settle out quickly in the catchment. The cleaning operations were completed at the end of October 2010. Mr. Shaver discussed the catchment structures being removed.

**4.c Hydrologic Balance: Other Sediment Control Measures**

Since the cleanup, a series of flash flood events have damaged the catchment structures and bent the steel weirs. Mr. Shaver expressed his concern over leaving the catchments in place due to the frequency of heavy storms and flooding in the area. Mr. Shaver recommended that the structures be removed but still under the West Ridge Mine permit in the event that they need to be used in the future.
