Topsoil pile is snow covered.

4.d Hydrologic Balance: Water Monitoring

The permittee has submitted third quarter water data to the Division. This information is reviewed by the Division in Salt Lake City.

8. Noncoal Waste

The site was clear of non-coal waste.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

13. Revegetation

The topsoil pile is revegetated. This can be seen in the spring through fall.

14. Subsidence Control

Subsidence information is in the annual report.

16.b Roads: Drainage Controls

The diversion were functioning as designed.

18. Support Facilities, Utility Installations

There were no new support facilities constructed since the last inspection.

20. Air Quality Permit

The Air Quality permit is DAQE-055-99. The permittee is planning to increase coal production for 2011. It is suggested that the permittee may want to review the amount of coal mined in a rolling 12 month period as stated in the Air Quality Permit. It may need to be increased.

21. Bonding and Insurance

The insurance policy will expire on June 1, 2011. This policy does include explosives coverage. The bond is \$2,117,000.
