## **2. Signs and Markers**

### **4.a Hydrologic Balance: Diversions**

Some of the road culvert have started to get sediment build-up. Permittee has stated that the company will have them cleaned out. The culverts are functioning as designed.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

Sediment pond contained a small amount of water. The pond is not likely to discharge in the near future.

### **4.d Hydrologic Balance: Water Monitoring**

A Notice of Violation was issued for failure to document visual inspections of the mine water discharge as required in the Mining and Reclamation Plan. The log book was lost and the permittee then stopped the inspections. A new book is on site and the permittee is complying with the requirements of the MRP.

## **8. Noncoal Waste**

The mine site was clear of non-coal waste material.
