2. Signs and Markers

The Identification sign is located at the main gate to the property. The sign meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

The topsoil pile was inspected with no signs of wind or water erosion. I informed Jay Marshall about taking soil samples as it is required in the Mining and Reclamation Plan. He was already informed about the soil sample requirements.

4.a Hydrologic Balance: Diversions

The diversions were inspected and complied with the performance standards. Diversions and culverts were open and would function in a storm event.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment pond and found no hazardous conditions. The sediment pond contained little water. This sediment pond is unlikely to discharge in the near future. There is no sides of erosion to the banks.

4.c Hydrologic Balance: Other Sediment Control Measures

The straw bales along the road were functioning as design hold back sediment. The permittee did clean out several straw bales prior to the inspection.

8. Noncoal Waste

The trash and other non-coal waste material were stored in trash bins. The site looked clean of non-coal waste materials.

There is no new support facilities since the last inspection.
