Many of the roads were extremely muddy. The snow was melting and the water was entering into the diversions as designed. The storage area which is relatively flat was a swamp. There were several inches of mud. It will take several days before the mine site dries up.

At the truck coal loadout area just above the main office, longwall equipment being loaded on to semi trucks. It is my opinion the equipment was going to be rebuilt. No coal trucks were being loaded during the inspection.

The longwall is idled until the end of the month. The longwall panel is currently being developed.

2. Signs and Markers

The identification signs were inspected. The information contained on the signs meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

The topsoil pile is still snow covered. This area is shaded from sunlight. There were no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

The diversions were functioning as designed. Water was flowing within the diversions during the inspection. Culverts were functioning as designed. As the water flows into the diversions so does sediment. The diversions most likely will need to be re-graded and culverts cleaned out after the snow melt. All drainage controls were functioning as designed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment and did not see any hazardous conditions. Water was flowing from the diversions into the sediment pond. The sediment pond did contain water but was not going to discharge in the near future. The embankment and slopes appear to be stable.

8. Noncoal Waste

I inspected for noncoal waste material on the property. The noncoal waste material was stored in trash bins. There were a couple of pop bottles in the parking lot.

10. Slides and Other Damage

I did not see any slides from the cut-slopes. Some of the road cuts have some minor amount of sediment going into the diversions.

16.b Roads: Drainage Controls

Road drainage was functioning as designed. Water from the snow melt was entering the design diversions.

18. Support Facilities, Utility Installations

No new support facilities were constructed since the last inspection.
