2. Signs and Markers

The Identification sign is located at the main gate to the property. The sign meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

The topsoil pile at B-Canyon was stable and surrounded by waddles. Very little vegetation is growing on the topsoil pile. This pile has not been seeded.

4.a Hydrologic Balance: Diversions

The diversions at the mine site were open and functioning as design. B-Canyon does not have any diversions.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond was stable and was not discharging during the inspection.

4.c Hydrologic Balance: Other Sediment Control Measures

The sediment control at B-canyon was using waddles. The waddles were placed around the disturb areas and the creek. All runoff would be treated by these waddles.

8. Noncoal Waste

There was no trash at B-canyon.

18. Support Facilities, Utility Installations

There was no equipment at B-canyon. A lock fence is in the portal to block access to the mine.
