2. Signs and Markers

The Identification sign is located at the main gate to the property. The sign meets the minimum requirements of the R645 Coal Rules.

3. Topsoil

Topsoil pile was snow covered and stable. I did not see any signs of wind or water erosion. In the summer vegetation was growing on the piles. Most of the topsoil is buried under the pad area. The approval by the Division was under experimental practice.

4.a Hydrologic Balance: Diversions

Diversions were spot-checked. All diversions were functioning as design. In the spring, the diversions will need to be cleaned out of sediment. This is an annual occurrence. No water was flowing into the diversions.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond did contain a small amount of water. I did not see any hazardous conditions to the pond. The embankments appear to be stable. The sediment pond is not like going to discharge in the near future.

5. Explosives

Magazine and cap boxes are located in the warehouse storage yard. These boxes are inspected by MSHA.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

The roads were dry and well compacted. There was no dust control problem.
