2. Signs and Markers

The mine identification sign is posted at the entrance into the mine site, at the point of public access. The sign is of substantial material and contains all of the required information in a clear and legible format.

4.a Hydrologic Balance: Diversions

The road diversions throughout the site were checked. These diversions were open and functional at the time of the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The upper sediment pond is frozen over with ice. The ponds were recently surveyed. Information relative to this survey will be forth coming.

4.c Hydrologic Balance: Other Sediment Control Measures

The wattles used along the access road into the mine site from the office going down canyon were checked and found to be functional.

5. Explosives

The powder and cap magazines are located in the upper most storage area. The magazines are properly signed and are also grounded against lighting strikes as required by law.

8. Noncoal Waste

Items of noncoal waste were observed at various locations throughout the mine site. These items were identified and site personnel contacted to pick the items up and place them in the appropriate storage containers.
