## **2. Signs and Markers**

The mine identification sign was checked during the inspection. The information is current. The sign does contain all of the required information. The sign is clearly posted as you enter the mining permit area.

### **4.a Hydrologic Balance: Diversions**

Several of the diversions along the road ways were observed to make sure that the snow removal activities that were occurring did not impede the diversions by a blockage of snow being pushed into the diversions. Care had been taken to not push snow into the diversions. The diversions observed were covered by a blanket of snow that had fallen there naturally. The diversions were open and functional.

### **4.b Hydrologic Balance: Sediment Ponds and Impoundments**

A small amount of ice is in the bottom of the sediment pond covered by a blanket of snow. The dikes of the sediment pond appeared stable. No visible hazards were observed associated with the sediment pond.

### **4.c Hydrologic Balance: Other Sediment Control Measures**

The straw wattles along the county access within the permit area were observed. The wattles are covered by a blanket of snow. The temperatures were cold enough that no melting or water flow was occurring.

## **5. Explosives**

Powder and cap magazines are properly signed and grounded as required by regulation.

## **8. Noncoal Waste**

No noncoal waste was observed outside of the designated containment area.
