2. Signs and Markers

The mine identification sign was checked during the inspection. The sign is posted at the entrance into the mine site/mining permit area. The sign contains current accurate information and also lists all of the required items set forth in the Utah Coal Rules.

4.a Hydrologic Balance: Diversions

The culvert outlet at the road contact point of the main mine road and the road that leads to the coal storage pile needs to be maintained. The outlet is still functional as water was observed flowing during the inspection.

A few of the straw wattles along the main road from the gate to the office area need to be maintained. This work should take place during spring cleaning.

The mesh energy dissipaters/mesh structures in the main diversion from the bath house area up to the shop need to have maintenance done on them during spring cleaning.

8. Noncoal Waste

A few items of noncoal waste were observed during the inspection. The items were documented and scheduled to be picked up.
