2. Signs and Markers

The mine identification sign is posted at the entrance into the mining permit area. The sign contains the name, address, phone number and mining permit number of the operator as required by law. The sign is in compliance with the coal rules.

4.a Hydrologic Balance: Diversions

The energy dissipators in the main diversion still need to be maintained and/or replaced.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond at the West Ridge Mine still needs to be cleaned. The dump truck is on site and the track hoe is scheduled to be mobilized to the site by the end of the week.

8. Noncoal Waste

A few items of noncoal waste were observed in some of the diversions. These items were documented by the operator to be gathered and placed in an approved noncoal waste storage facility.
