2. Signs and Markers

The mine identification signs are posted at access points from public access to the mining permit area as required by law.

4.a Hydrologic Balance: Diversions

Road diversions were open and functional. Maintenance work was taking place during the inspection by surface personnel.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Cell A and B of the sediment pond were dry. Points of access used during the sediment pond cleaning where ramps were built are beginning to show sign of vegetation being re-established.

16.a Roads: Construction, Maintenance, Surfacing

Roadways at the mine site have been recently graded and are well maintained.
