2. Signs and Markers

The mine identification signs located at the pump house and at the entrance into the West Ridge Mine site were both observed during the partial inspection of the West Ridge Mine. Both of these signs contained the name, address, phone number and mining permit number in their contents. These items are requirements of the coal rules to be posted at all public entrance/access points into the permit area. Both signs were determined to be in compliance with the Coal Rules.

4.a Hydrologic Balance: Diversions

The diversions at the West Mine Site were open and functional at the time of the partial inspection. Several rocks need to be removed from the diversions that lay against the hill side. The rocks have rolled off the hillside from freezing and thawing conditions.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment pond (Cell A & B) appeared stable during the inspection. No visible hazards were observed in association with the Sediment pond.

4.c Hydrologic Balance: Other Sediment Control Measures

Straw wattles used in road diversions were all well maintained and functional.

8. Noncoal Waste

The mine site was free of noncoal waste items at the time of the inspection.

16.a Roads: Construction, Maintenance, Surfacing

The interior road ways associated with the mine site were well maintained. Snow had been plowed from the road surfaces providing access to all parts of the mine site.
