2. Signs and Markers

There is an identification sign posted on the fence at the pump house below the main mine site and on a post at the entrance into the mining permit area. The signs contain the name of the company, address, phone number and mining permit number. These are requirements set forth in the regulations. The signs are in compliance.

4.a Hydrologic Balance: Diversions

Several locations of road diversions were found to contain snow that had been pushed into the reaches of the diversions. These locations were identified during the inspection and the material needs to be pulled back out of the diversions.

7. Coal Mine Waste, Refuse Piles, Impoundments

No refuse pile is associated with this mining permit.

16.a Roads: Construction, Maintenance, Surfacing

Snow removal has taken place on the roadways throughout the mine site.
